






Study Description

"...identify and evaluate options to improve transportation mobility, safety, access, and connectivity between the Seward Highway, near 20th Avenue and the Glenn Highway, east of Airport Heights. The project will also identify ways to improve access to and from the Port of Alaska to the highway network."

Benefits of PEL Process for Projects



- Include input from agencies and stakeholders throughout process
- Accelerate project delivery
 - Carry work and decisions forward
 - Fewer re-do's
- Flexibility
 - Size & type of solutions
 - Implementation planning



Public Input in the PEL Process





- Multiple public involvement opportunities and methods
 - Public meetings during each phase
 - Newsletters, website, email updates



- Four committees established:
 - Community Advisory Committee
 - Technical Advisory Committee
 - Resource Agency and Tribal Committee
 - Executive Committee



- Stakeholder input is used to shape solutions
 - Purpose and Need
 - Range of Alternatives
 - Recommended Alternative(s)


